Selection criteria for CASP allocation:

1. It must be a land reform initiative.
2. It must contribute to food security.
3. It must have a minimum lease agreement of 5 years, at the date of application, as a food security project.
4. It must have a minimum lease agreement of 9 years and 11 months, at the date of application, as a commercial project.
5. Priority will be given to projects that benefit women, youth and disabled.
6. The project must have the potential to create jobs.
7. It must have the potential to become economically viable and sustainable.
8. The application must show that the grant will have a significant positive impact on the viability of the initiative.

9. Previous receipt of government funding or support will be considered.

All sections of the application must be fully completed. The following documentation and information must be provided as part of the application to avoid disqualification:

1. Certified copies of all beneficiaries' IDs.
2. Tax clearance certificate for registered entities.
3. Information on the availability of water on the site.
4. A copy of the lease agreement signed by the owner of the land.
5. A projected income and expenditure (cost)
6. A letter of commitment from commercial partners in Farm Worker Equity Schemes detailing their financial capability to participate.
7. A signed copy of the group's constitution.

1. Dit moet 'n grondhervormingsinisiatief wees.
2. Dit moet bydra tot voedselsekureit.
3. Vir voedselsekureitprojekte moet daar ten tye van die aansoek 'n minimum huurooreenkoms van 5 jaar in plek wees.
4. Vir kommersiële projekte moet daar 'n minimum huurooreenkoms van 9 jaar en 11 maande in plek wees.
5. Prioriteit sal gegee word aan projekte wat vroue, jeug and gestremdes bevoordeel.
6. Die projek moet die potensiaal tot werkskepping hê.
7. Die projek moet die potensiaal hê om ekonomies lewensvatbaar en volhoubaar te wees.
8. Die aansoek moet toon dat die befondsing 'n positiewe impak op die lewensvatbaarheid van die projek sal hê.
9. Vorige staatsbefondsing en ondersteuning.

Alle afdelings van die aansoekvorm moet volledig voltooi word. Die volgende **dokumentasie** en inligting moet saam met die aansoek ingehandig word om diskwalifikasie te voorkom:

1. Gesertifiseerde kopieë van ID's van alle begunstigdes.
2. Belastingklaringsbewys vir geregistreerde entiteite.
3. Inligting rakende beskikbaarheid van water op die grond.
4. 'n Afskrif van die huurooreenkoms geteken deur die grondeienaar.
5. 'n Geprojekteerde inkomste- en uitgawestaat.
6. 'n Brief van kommersiële vennote ter bevestiging van hul verbintenis in aandeleskemas wat hul finansiële kapasiteit aandui.
7. 'n Getekende afskrif van die groep se grondwet.
