#### How can livestock auctioneers mitigate the risk of spreading FMD?

To protect yourself and our province, every auctioneer in the Western Cape Province should implement the following steps:

- 1. Auctions held within the Western Cape should be conducted strictly in accordance with the <u>Agricultural Produce</u> <u>Agents Council (APAC) rules (Biosecurity Rules for Livestock Agents – NAHF)</u>
- No cloven-hoofed animals should be purchased and moved from Disease Management Areas (DMA) or from properties under quarantine. The current FMD DMAs are declared in <u>Government Gazette Notice 50977 of 26 July</u> 2024.
- 3. Cattle vaccinated against FMD in a DMA should be branded with an "F" mark, usually on the right-hand side of the neck, and should not be moved, except when it is directly to an abattoir for slaughter, under cover of a red-cross permit issued by their state veterinarian. If you see or hear of cattle in the Western Cape with such a brand, please report them immediately to the local state veterinarian.
- 4. Do not move animals if they may have a disease. The consignor and consignees of the animals are required to provide declarations in accordance with the July 2024 Government Gazette Notice. The health declaration from the owner (seller) of livestock, as well as a declaration by the recipient (buyer) to isolate the animals at destination (unless they are destined for direct slaughter) must accompany all consignments. The auctioneer should require these documents in accordance with Section 26 (1) (ii) of the Animal Disease Act and he may refuse to auction the animals if it is not provided.
- 5. In addition, it is also within your right to require a **veterinary health certificate** for all animals that are moved into the province from any other province, especially the high risk neighbouring Eastern Cape and KwaZulu-Natal provinces, where active outbreaks of FMD are currently reported.
- 6. To monitor and investigate possible high-risk livestock movements in and to our province the Western Cape Veterinary Services made an online cloven-hoofed movement notification portal available. Every livestock owner who wants to sell animals should register and use the registration link to **report every consignment of livestock movement**. An automated reference number is emailed and can be used as proof of compliance and cooperation to protect our province. - 7. Every truck should be washed to remove all organic material after every consignment of animals have been unloaded and before the next consignment is loaded, preferably before leaving the farm/abattoir and at the Depot. This should be followed by disinfection with a disinfectant registered to kill the FMD-virus. The correct concentration and wetting times must be adhered to. A valid **"wash-certificate"** should accompany the truck and should be showed to the auctioneer before livestock are loaded.
- 8. It is highly recommended that bedding and feed from a livestock transport vehicle be burned, buried or composted immediately as the FMD virus can survive for up to 6 months on such material.
- 9. If any person becomes aware of a suspect high-risk movement of livestock into our province or your area, **please report** it to the local livestock theft unit of the SAPS and to the local state veterinarian.

- Should any suspicious clinical signs (salivation, blisters in the mouth, limping or hoof lesions) be seen, it should be reported to the local state veterinarian immediately and such **animals must not be moved under any circumstances**. The contact details for the local state veterinary office are available at: <u>https://rb.gy/tii7zw</u>
- 11. Traceability of animals is not only useful to prove ownership, but it is a legislative requirement in terms of the Animal Identification Act, <u>Act No. 6 of 2002</u> and the Stock Theft Act, <u>Act No. 57 of 1959</u>. It can also help to trace movements of animals, which is valuable for disease control purposes. As livestock auctioneer it is prudent to require that the animals that you auction should be identified correctly with the registered brand of the animal owner (seller).

Together we can prevent FMD from entering our province and the severe economic losses that can accompany this.
